Frequently Asked Questions about becoming a Parish Councillor

Q. Who can become a Councillor?

You can become a Councillor if you:

- are 21 or over on the day of nomination
- have property in or work connections with the UK
- are a UK, Commonwealth EU or Irish Republic citizen
- have not been declared bankrupt
- you are on the electoral role in the Council area
- Q. Is it helpful if I have to have a degree in Nuclear Physics?
- A. No, but this could be helpful if we ever needed to look at the issues of creating a Unified theory of Quantum mechanics and Gravity.
- Q. Does a background in planning and legal issues associated with knowledge of development in the rural environment help with my chances of selection?
- A. This would definitively give you a head start over the majority of candidates!!!!!!!!
- Q. How many times a year do you have meetings
- A. Six, once every two months on the last Thursday of the month.

- Q. How long do council meetings last?
- A. Typically 2 hours from 8.00 to 10.00pm
- Q. What is the salary?
- A. None, this is purely for the pleasure of serving your community.
- Q. Do I get an OBE?
- A. Perhaps, maybe, depends!!
- Q. Where are the meetings held?
- A. The village hall.
- Q. Will there be an election?
- A. Possibly but only if 10 parishioners write to TVBC, otherwise the candidate will be co-opted by the current council.
- Q. What are the big issues MPC addresses?
- A. Traffic and planning.
- Q. How soon do you need me to apply?
- A. Immediately.
- Q. What do I do to apply?

MATTERS ARISING (Abridged version)

FOOTPATHS

Mrs Horrell (Footpath Warden) explained that at Hook Lane, which is at the top of the hill coming up Green Lane in the direction of Grateley, an application has been made to make the bridle path open to all traffic. Mrs Horrell explained that if it could be proven that in the past vehicles had used this path, then this application could be successful. The only cause for objection would be if this was not the case. This application is currently number 55 on the list of such applications. Mr Colbourne told the council that there is much discussion in parliament at present concerning such matters. Monxton Parish Council has written a letter of objection to HCC already. It is uncertain at present who owns the land. Mrs Horrell asked the Chairman to contact the footpath representative of Amport Parish Council to see if they knew to whom it belongs, as the land is on the boundary with Amport.

The field at Monxton Oakcutts is still ploughed over despite past conversations had with the owner. The Chairman told the council she will speak to Mr Machin again to see if he can help, although the land does not actually belong to him.

The chairman told the council that TVBC have provided a dog waste bin but unfortunately have put it in the wrong place up at Sunnybank. They will relocate it and provide a green bin rather than the red bin.

VILLAGE HALL

The lay-by surfacing is due to be completed by Hampshire Highways in the Spring. Although the grass on this area at present appears to have a disease this should adjust itself.

The village hall had an extremely successful 'cinema' evening this month. The performance was sold out and £160 profit was made. There will be another film in March.

TRAFFIC CALMING GROUP

Mr Leon Allen told the Council there was little to report and asked about the five Parish's meeting, which was held on the 20th January 2005. This meeting was held in the village hall with representatives from Grately, Quarley and Amport. The main topic of discussion being traffic issues through the villages. Mr Allen explained that on the morning of 27th January he had taken photos of a very large lorry coming from ATF/Siteweld through the village, certainly over the 7.5 tonnes previously agreed. In general though, following the agreement between TVBC and ATF most lorries being used are now under this weight limit.

Mr Allen explained that some further traffic surveys would be taking place in the Spring. Mr Colbourne advised that traffic from the DLO was a major contributor to the volume of traffic and that the car parks at the DLO are now full to capacity.

FINANCE

Mr Eaglesham confirmed that he has filed the paper work for next year's precept 2005/2006 as £5,010 as previously agreed.

At this point the proposed Monxton and Amport village party was discussed. Mr Eaglesham told the council that although the council is not able to donate any money towards such events, it can loan money to the village hall up to the amount of £500. This money can be used as advance payments where required and then returned after ticket sales.

It was suggested that a team of helpers get together as soon as possible to begin the organisation. Any volunteers to contact Mike Cleugh on 01264 710 276.

Note: TVN.00022/1/2/3 Mrs Ryan told the council that she has spoken to Mr Machin of Prospect Farm again. As far as he is concerned they are operating legally and have been doing so for over 10 years. His daughter has arranged a meeting with TVBC to discuss the matter.

TVN05969/5 A site inspection and informal hearing took place on 26th January, which the Chairman and Mrs Richards attended. Mr Beattie explained his case at length. The issue of traffic was mentioned and while the site at present does not cause any problems with traffic there is a concern that should permission be given this will not be the case. The plot is used for a horticultural business but it is the extra non-horticultural vehicles that will be the problem. A decision will be given in due course.

TVN.07241/3 – Erection of storage building and provision of manege – Broad Road. The Chairman has again asked Mrs Smith to remove the unsightly vehicles from the site.

Monxton Parish Council Minutes (Abridged version)

MATTERS BROUGHT BEFORE THE MEETING BY PARISH COUNCILLORS

The Chairman told the council that she had recently attended a presentation by TVBC concerning 'Development Control and the 2004 Act.' The seminar was to present future planning regulations and some changes, most of which were not relevant to Monxton. The Chairman did advise that once planning permission is granted, work must commence within 3 years instead of the current 5 year period.

JENNIFER RICHARDS RESIGNS FROM THE MONXTON PARISH COUNCIL

Mrs Jennifer Richards announced her resignation from the Parish Council. The chairman accepted her resignation with regret and the council expressed their gratitude and thanks for all her hard work and support over the past years. A Potted History of Dene Cottage



Dene Cottage, located at the far end of Green Lane, is the second to last house on the left as you leave the village in the direction of Grately. It sits between Farm Cottage to the left and Beechurst to the right.

It is believed that the house was built in the 1740's and is a little unusual as in that it is attached to Beechurst, which was built some 100 years later. The two houses were once connected through a door that joins the respective dining rooms of each property; this doorway has since been sealed. The house has a thatch roof and cob walls, which contrasts with Beechurst's Victorian brick and tile construction.

In the 1970's, the house was extended to the side and rear to provide an additional bedroom and space for modern conveniences such as a bathroom and kitchen! The word Dene means 'wooded valley', which describes the cottage perfectly as it backs onto steep bank with the garden actually sitting higher than the roof line of the cottage.

From the patio area at the rear, a short brisk walk up a winding path takes you to the garden, where you can see fantastic views of Monxton, Amport and the fields beyond. The current owners moved in some two years ago and have had to undertake some significant internal modernisation in order to bring the cottage up to today's standards.
